## District 16 ACBL Treasurers Report YTD March 31, 2021

Attached is the Statement of Financial Activities for the three months of 2021 ending March 31, 2021 and the Statement of Financial Position depicting the financial condition of District 16 as of March 31, 2021.

Normal operations generated expenses in excess of revenues by \$1760. Expenses were driven mostly by education expenses for speakers and workshops. Additionally money was spent on an annual zoom license, check stock, stamped envelopes and award pins.

At the end of the period there was \$6,524 in the District's primary cash account, plus \$3,033 in the Scorecard bank account, and an additional \$183,632 in an interest earning Vanguard account, for total cash assets equaling \$193,189. Cash flows for the period were a negative \$1,760 due to the lack of revenues.

There remained \$35,493 of unused Grass Roots funds to be used for the future promotion and support of the GNT and NAP events. There is also \$27,838 earmarked for use in future D16 NABCs.

As evidenced by these financial statements, the District continues to be in a strong financial position and is in good standing to continue its mission.
